**ELIGIBILITY:** The candidate must be a second or third-year Black female enrolled in law school in the State of Georgia in good academic standing.

**CRITERIA:** Scholarships will be awarded to applicants who demonstrate one or a combination of criteria, including academic achievement, leadership, and a strong commitment to the profession and her community. Financial need will be considered in awarding the scholarships, but is not a prerequisite. A strong candidate will highlight her involvement in programs that affect and promote the advancement of Black women in the profession and community, as well as her abilities as a leader.

**AWARD AMOUNT:** The Foundation will award scholarships in quantities and amounts to be determined by the Foundation.
